



1. Members must produce their membership card to gain admission to the club.
2. Any Member found lending his or her card to another person shall be suspended.
3. Members introducing a visitor must enter their guest's name in the Registration Book and be responsible for their conduct whilst on the club premises. The Board of Directors or any delegated authority reserves the right to refuse admission of any visitor.
4. Any person shall remain on the premises only as long as the introducing member.
5. Any person who has been rejected as a candidate for membership, or has been expelled from the Club, or whose name has been erased from the membership register for non-payment of dues or any other reason shall not be permitted as a visitor.
6. Members shall not take away from the Club premises any articles or property of the Club without the permission of the Secretary/Manager or responsible officer.
7. No mobile phone or camera is to be used throughout the club unless requested by management.
8. Meetings of any description are not to be arranged without the permission of the CEO or Board of Directors.
9. No subscription list is to be canvassed, conducted or exhibited in the Club without the permission of the Secretary/Manager or the Board of Directors.
10. Members are not allowed to bring animals (other than Seeing Eye dogs) into the Club.
11. No part of the Club premises shall be used for the purpose of organized betting or gambling or the playing of any games which are considered by the Board of Directors to be injurious to the interests of the Club.
12. No debts of any illegal nature shall be incurred within the Club.
13. Members of the Club shall not be less than eighteen years of age.
14. During periods when the Club trades past 11:00pm, members and their guests only will be permitted to enter the Club after this hour.
15. No intoxicated person shall be allowed on the Club premises.
16. Any Member being intoxicated on the Club premises shall be asked to leave and may be suspended from all Club privileges.
17. The Club adheres to the Clubs Queensland Code of Practice for responsible gaming and will ensure all efforts are made to help problem gamblers.
18. A responsible officer of the Club is a Director, Secretary/Manager or delegated person.
19. No members shall reprimand any servant of the Club. All complaints against any servant shall be in writing to the Board of Directors or CEO.
20. No member shall distribute "how to vote" tickets within the Club.
21. Dress: Members are requested to observe a decent standard of dress at all times. Smart casual dress is required in both lounge areas at all times. Work clothes, football shorts and rubber thongs are permitted in the main bar area until 7:30pm week nights. No work clothes on weekends. No swimwear, shorts of immodest length, no tank tops, singlets or torn jeans. No sand shoes, dirty running shoes or football boots. No t-shirts with objectionable writing or pictures will be permitted at any time. Final decision on acceptability of dress will rest with the doorman on duty.
22. Children will be permitted in designated areas only, accompanied by parents or another responsible adult. Children must leave the premises by 9:00pm. Children may attend private functions in other areas of the Club.
23. The Children's Activity Centre is open to all members' children who are over 3 years of age, toilet trained & 12 years of age and under.
24. No children will be allowed to the cabaret shows.
25. Members involved in any altercation, abusive language or any other misdemeanour will be asked to leave the Club and will receive an automatic minimal suspension of three months. However, at the following meeting of the Board, this suspension may be extended according to the "Suspension report" before the Board.
26. Any visitor patronising the Club more than three times shall be required to become a Member.
27. The Directors reserve the right from time to time to amend or add to these bi-laws.
28. The members shall be one classification of ordinary members. A nominal fee set by the Board of Directors shall accompany this membership.
29. Any matter connected with the Management of the Club not provided for in these Rules shall be dealt with by the Board of Directors whose decision shall be final and binding.
