## PROXIES

- (d) A facsimile of a written appointment of a proxy or a power of attorney is valid.
- (e) Subject to the Law, the Director's or Chairperson's decision as to the validity of a proxy or power of attorney or a facsimile thereof will be final and binding.
- (f) An instrument appointing an attorney or a proxy and, the power of attorney or authority (if any) under which it is signed or a copy of that power of attorney certified as a true copy by statutory declaration or a facsimile of any of the documents referred to above must be deposited at the office of the Club not less than 48 hours before the time scheduled for commencement of the Annual General Meeting (or any adjournment of that meeting) at which the person named in the instrument intends to vote.
- (g) A person appointed proxy is not entitled to vote if the member who gave the proxy is present at the Annual General Meeting.
